### ***Master Zailian Kaipeng***

Zailian Kaipeng was a patient suffering from the last stage **Cancer (Bilateral Retinoblastoma)** for more than a year and belonged to a very underprivileged poor family in a remotest village under

3 Years old, Male, Son of - Mr. Nirbanglal Kaipeng and Mrs. Chengmaitee Kaipeng From - Nupangrumba, Twidu, Amarpur, Gomati, Tripura. Medical treatment facilitate to the patient at Regional Cancer Institute, Agartala, Tripura and Artemis Hospital, Gurugram, Haryana.

After rigorous efforts by the Hospital Medics Faculty to revive back the patient for 43 days, when master Zailian was emerging healthier, his battle ended breathing his last breathe on 25.11.2017 (0332 hours) at Artemis Hospital, Gurugram.



### ***Smt Lakhirani Tripura***

Mrs. Laxmi Tripura, 41 Years, Female, Wife of late Tikkamoni Tripura, with two innocent Children Ms. Urmila Tripura (7 years) and Mr. Rajmoni Tripura (4 Years), From Chittamara, Sub-Division: Belonia, District: South Tripura, State: Tripura

Laxmi Tripura was a patient suffering from the last stage Breast Cancer for more than a year and a widow with two innocent children belonging to a very underprivileged family.

Mrs. Laxmi's medical treatment has started on 10.11.2017 and continued till 05.06.2018, when she battled for her last breathe leaving behind two children. With none to look after the children, who were parentless now, both Ms. Urmila and Mr. Rajmoni were now take care by Mr. Budhilian Hrangkhawl, member LPT.



### ***Master Dhanika Tripura***

6 Years old, Female, Son of Mr. Dharma Kumar & Mrs. Sashibala Tripura, From Nalin Para, Battali, Longtarai Valley, Dhalai, Tripura. suffering from Acute Lymphocytic Leukemia on both eyes and belonged to a very underprivileged family.

It was during the month of November 2017, when video images of Dhanika was caught in the attentions of our trust member on social media and It was at this juncture our team visiting Dhanika in the Hospital and started her medical treatment at Dr. B. Borooah Cancer Institute, Guwahati. Without any further delay.

The doctors showed less confidence in her recovery stating that the survivability was less than 5% and started the induction chemotherapy on Dhanika. "Her medical treatment will take 24-36 months period" - said the treating doctors.



### ***Mr Santosh Debbarma***

25 Years old, Male, Son of Late Upendra Debbarma & late Mangaswari Debbarma, From - Nutan Dagma Kami, Daruka Mura, Sidhai, Mohonpur, West Tripura. Santosh was a patient suffering from Paralysis on both legs without any treatment for almost-

two years and belonged to a very underprivileged family in a remotest village under Mohonpur Subdivision.

Being parentless and poor, He was living in a miserable condition along with his elder brother, Mr. Usha Ranjan Debbarma, and was expecting for his last days being bed-ridden. It was during the month of October 2017, when a Video of a particular paralyzed man going viral in Facebook was picked up by our LPT team and admitted him at Agartala Govt Medical College to start his medical Treatment.

  - (iii) In the case of the receipts & payments accounts of the receipts and payments for the year ended on that date.




