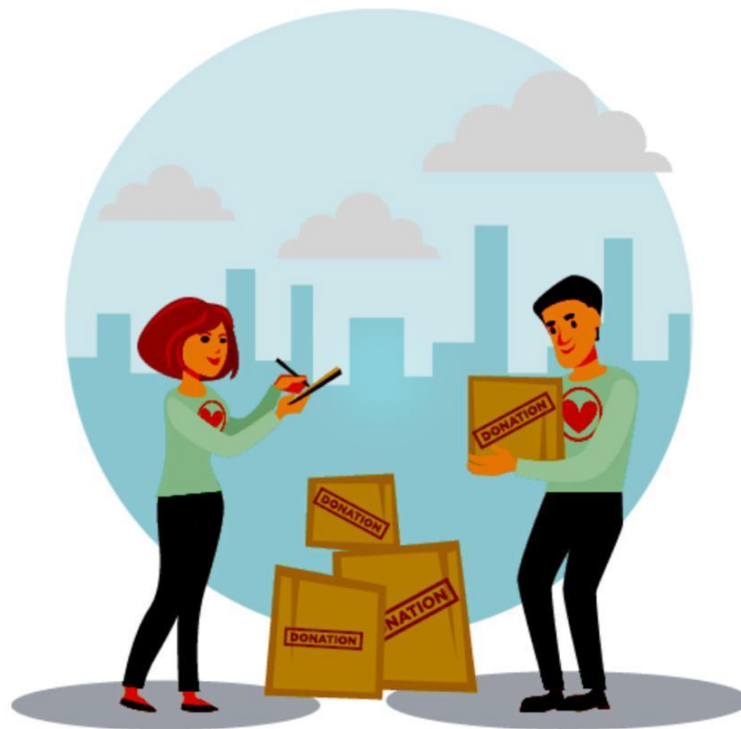

Aid Distributions



With regard to Aid allocation, LAM PHUNUKNAI TRUST aims to provide help to people suffering from Natural calamities such as Cyclone, Flood, Earthquakes, motor accidents etc. So far our funding source and the donation we received from donors seems to exert a great influence on our aid allocation decision. We try to allocate aid according to some strategic considerations and to respond to the need of beneficiaries accordingly. We believed that we are getting an immense support from the people by their donations to our organization on that note we can be concern and also could be the voice of the underprivileged ones. We believed Our hard work can be seen reflecting in the society. The names of beneficiaries who received aid allocation through our LAM PHUNUKNAI TRUST organization in the financial year of 2018-19 are as follows:

Cyclone Affected Area, Lefunga RD Block, West Tripura



On 07th May 2018, the devastating heavy storm cyclone shows its mercilessness to poor families under Lefunga Block Areas, recklessly destroyed everything coming in its pathway affecting many family members. Seeing the huge damaged caused, we prepared ourselves to contribute in every possible way with food, drinking waters, medical aids, warm clothes etc.

And subsequently, on 08.05.2019 and 09.05.2019, our Team visited the Relief Camps and provided every help possible in the forms of, necessary goods like Rice, Daal, Eggs, Cake, Biscuits, Medicines and do the necessary health checkup, where we covered approximate 1134 cyclone affected family members at 6 relief camps, like RAJGHAT, MAIKHOR, UJJAN FATIKCHERRA, SWNGLWNG; KUMARBIL and SARBAJOY Relief camp under Lefunga RD Block, West Tripura.

Aid distribution cum Medical Camp at Dhalai Tripura



On 09.12.2018, our team has organized a Aid distribution cum medical camp for 550 families members including children to be benefited. Where we distributed Blankets, Fruits, Notebook, Pen, Pencil, Eraser and Sharpener for students as well as Medical Health Camp was also conducted at Harincherra SB School, where SDM, Ambassa as well as DCM, Ambassa attended the programme.

Aid distribution cum Medical Camp at Dhalai Tripura

During this said Medical camp our member Dr. Biplab Jamatia, MBBS, MD(AIMS) ; Dr. Amulya Debbarma, MBBS, MD(Gynaecologist) and Dr. Pritam Debbarma, MBBS, Medical Officer, were present to provide the basic medical consultations to our needy Tigrasa peoples.

Medical Camp for Malaria cum Aid Distribution at Dhalai



Ratannagar VC, Dhalai Tripura was reported to be one of the badly affected Villages due to Malaria outbreak under Dhalai District during September, 2018 immediately after the Monsoon was on its transitional period. Our team came together once again and decided to do something rather than seeing and hearing about people being admitted in hospitals and dying.

Medical Camp for Malaria cum Aid Distribution at Dhalai



The Team consequently planned to organize Malaria Awareness Campaign involving Medical officers which also included Relief & Health Camp on Community basis Aid at Malaria-stricken of Ratannagar VC of Dhalai District on 02.10.2018. Where Dr. Amulya and Dr. Aichuk were the key Medics who checked the inhabitants and free medics were given while blood tests were done by the local health workers.

Medical Camp for Malaria cum Aid Distribution at Dhalai



All together 250 persons were checked by the doctors, 120 persons were done malarial tests, 100 nos mosquito nets, 200 nos mosquito repellent creams (odomos), 200 nos dettol soaps, 50 kilo of fresh apples, chocolates for children were donated. Simultaneously, khichdi and egg was served to all the attendees and financial aid to 4 families whose members had passed away due to malaria were given and also to families whose members were found to be positive with malarial PF tests, financial aid was given for treatment.

“why not celebrate and commemorate the TRING in a meaningful serviceful manner and on humanitarian cause.” Out of this thought, a plan to reach out for community help and to distribute Aid was decided and eventually shaped into a beautiful event at Akhaliacherra High School, Harep, Sonaram, Simna, West Tripura on 19th Dec 2018 during the celebration of Tring 1429, Our team donated educational kits and sweets to 100 nos. local students and blankets and warm clothes to 25 nos. Commoners.

Aid Distribution to Mrs Sumati Tripura, Dhalai Tripura



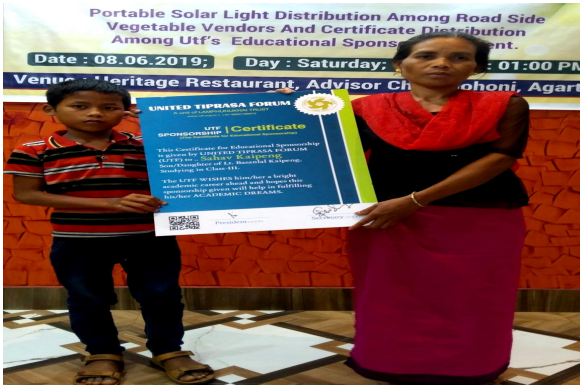
Mrs. Sumati Tripura, 43 Years, from Magroom VC, Rupaicherri, Sabroom South Tripura District. She was a poor mother badly stricken by poverty and belonged to a very underprivileged family in a remotest village under Sabroom Subdivision. On 15.09.2018, in one of the daily Bengali local newspaper, news clipping about a woman and her child that occurred on 14.09.2018 was reported. The news content cited that the mother was in an act of killing her own child near the bank premises of Tripura Gramin Bank, Sabroom Branch and the commoners saw this act of the woman and handed her over to the police personal. Later she was released and allowed to return back home. Coming across this news, Mr. Manoj Debbarma, member of our trust and his team decided to visit her family and decided to provide some help from our side. So the team headed by Mr. Manoj, visited Mrs. Sumati's family on Sunday dated 16.09.2018 and donated her family by providing food materials, medicines, warm clothes and some financial help.

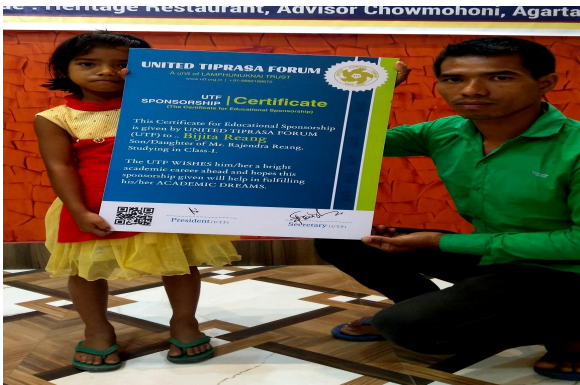

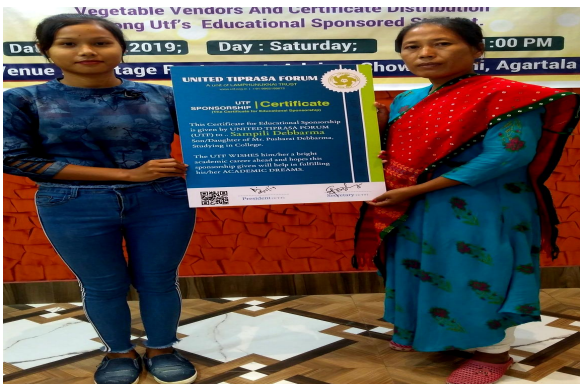

Laisem Reang, divorced mother of 3 children belongs to a very underprivileged poor family in a remotest village under Ambassa Subdivision residing under a thatched roof.

It was during the month of November 2018, when the Our Team was planning of executing the objectives of LPT which included aid in construction of Houses for poor and needy. At this time around, one of our member came across a poor women from 4 Mile, Ambassa, Dhalai Tripura whose name is Laisem Reang, residing under a thatched roofed torn house and surviving with extreme difficulty even for a square meal and drinkable water. Under these conditions, the our team persuaded upon what sort of help would be beneficial for her. Accordingly, a team visited the family and discussed with her about the decision of our trust to help her constructing a house. Accordingly, one time contribution from the members as well as well-wishers was initiated from the 1st week of November on a mission mode basis. And house construction work for Mrs. Laisem soon started from 15.11.2018 under the supervision of Mr. Jouspaul. With much efforts from the team LPT and well-wishers, a house worth living for Mrs. Laisem and her family could be constructed after spending Rs. 126000/- and on 09th December 2018, the newly constructed house was inaugurated and handed over to Mrs. Laisem by Dr. Biplab Jamatia, advisor for LPT present during the inauguration programme.

Medical Treatment

As we know there many underprivileged people who couldn't afford to get access to proper medical treatment because of the their financial instability. We believe that sick people need to be seen by trained health workers so they can get the right diagnosis, the right treatment and the right follow-up care. We aim to reach out to every people who needs financial assistance for their treatment. We also try to delivered medicines for patient at their door steps.

Our performance demonstrates our strong operational resilience and ability to cater to diverse patient needs in challenging situations. Our project activities remained robust. We are committed to Our ongoing project activities and ensure to our success working to improve the lives of patients in need. We also continued to make progress in building trust with society, we Plan to work towards these goals to ensure that, Access to medicines is a vital aspect of quality health care. When working in collaboration aims to ensure the processes for planning, monitoring and evaluation which are clearly defined.



Master Keffrien Reang

Age: 3 Yrs Son of Mr. Sanjit Reang & Mrs. Ruati Reang; From Laldinga Para, Chailengta, Longtraï Valley, Dhalai District, Tripura, suffering from Retinoblastoma and belonged to an underprivileged family with his parents hardly earning Rs.3500-4000/- only per month.

After few days of treatment at Dr. B. Baruah Cancer Institute of Guwahati, they had no choice but to leave the hospital due to financial crisis and was deciding to return home. They were accordingly, approached by the team Lamphunuknai Trust, upon decision to help by the LPT decision making body, and his parents too agreed and his treatment continued. In total, he was received 6 Chemotherapy treatment under observation of LPT Team till 23.04.2018 after which, the Doctors recommended for his eye surgery. Accordingly, on 16.05.2018, Keffrien underwent eye surgery at Shankar Nethralaya Hospital successfully.

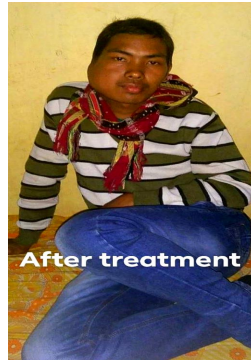


Following which, the patient was brought back home however the Doctors suggested for 2nd phase of Chemotherapy within another week. However, the carelessness in the part of the parents dredged in a severe malarial fever in Keffrien that despite his admission to Manu Subdivisional Hospital made way for his never returning sleep bidding us all in floods of sorrow on 6th June 2018.

In the financial year of 2018-2019, with regard to the financial assistance of medical treatment, a patient name Rahendra tripura 25 years old S/O of chandrajoy tripura from dhalai district who was suffering from acute pleomorphic adenoma in parotid gland had been receiving the treatment in GUWAHATI MEDICAL COLLEGE AND HOSPITAL (GMCH) for almost a year with the financial assistance of LAMPHUNUKNAI TRUST.



It had been almost a year that his medical treatment was initiated in the guwahati medical college with the financial support of our organization whereas due to some physical complications he had lost his life.
